

MEETING MINUTES

The North Central Florida HealthCare Coalition held its monthly meeting in person on August 23, 2023, at 1:30 at UF Health Gainesville Professional Park, E107 Conference Room, 3300 SW Williston Road, Gainesville, FL 32608.

CALL TO ORDER

The meeting was called to order by the Chair, Matt Ferguson with the validation of a quorum, with the following Board members present:

Welcome & Introductions

Chair, Matthew Ferguson welcomed everyone to the meeting.

Approval of Minutes

The minutes from July 2023 were provided to Board members via electronic mail and July Meeting Packet.

The Chair called for a motion of approval. Mr. Long moved approval; Ms. Woods seconded; Motion carried.

FINANCIAL

Finance Report

Ms. Suzanne DeKay presented the finance report for July 2023.

The Chair called for a motion of approval. Ms. Woods moved approval; Mr. Long seconded; Motion carried.

MANAGEMENT AND **A**DMINISTRATION

• Project Funding Update Staff reported that the HCC Alliance Board met on August 17th to review and prioritize the submitted projects that were deemed allowable per FDOH. All agencies that submitted a project application were notified of the decision(s) made by the Alliance Board. Six projects were funded through HPP funding totaling to \$197,463.03, and 3 projects were funded through the Florida Hospital Association (FHA) Infectious Disease funding totaling to \$133,280.00. Staff reports only one of the projects was not approved by the Alliance Board, and they heeded the guidance of FDOH who allowed the project but did not recommend funding approval as the equipment was seen as daily use, and not disaster related.

BUSINESS

New Members

Six (6) new member requests were presented for membership.

The Chair called for a motion of approval of the members. Mr. Long moved approval; Ms. DeKay seconded; Motion carried.

Pediatric Restraint Distribution

HCC staff provided an overview of the pediatric restraint project made possible through the HVA gap funding the HCC received for FY22-23. Staff reports all county/municipal EMS agencies were surveyed on their need for pediatric restraints (PediMate+, Neo Mate, KangooFix). Staff used the survey results to purchase pediatric restraints for the requesting agencies. All the restraints have been received by the HCC, and the HCC is working on distributing the equipment. Most agencies have received the restraints.

TRAINING AND EXERCISE

Chemical Catastrophe: A Virtual Train Derailment Exercise

Staff shared the upcoming virtual tabletop exercise series offerings for the membership. This series will have two delivery offerings with the same scenario. This series scenario is shelter-in-place/chemical incident. Attending this exercise can allow members to meet their CMS 'Exercise of Choice' requirement.

Member Reports and Open Discussion

Hospitals – Ms. Suzanne DeKay, from UF Health Gainesville, reports there is nothing major to report for their hospital. Ms. DeKay followed up on the Pediatric Surge TTX and the progress on the After-Action Report.

Mr. Ebbin Spellman, from UF Health Gainesville, reported on Florida Week at the CDP in Anniston, AL, and it will be held in April of 2024. UF Health Gainesville is hoping to send one or two higher leadership personnel to attend the week-long training. Mr. Spellman reported they are working with the VA hospital to plan and implement a tabletop exercise. The exercise scenario will include an influx of patients who had been exposed to chemicals. From this TTX, they hope to collaborate with other area hospitals to conduct a full-scale exercise with this scenario. The TTX is planned for some time this fall, prior to the holidays.

Emergency Management – Mr. Jason Long from Lafayette County EM reports they are storm ready.

Mr. Glen Hammers from FDEM reports he is the new Region 3 Coordinator, and he comes from Region 6. Reports the next Region 3 quarterly meeting will be sometime in September in Gilchrist County, and he will be sending out the meeting invites soon.

Public Health -

Ms. Casey Ditter from DOH Lafayette/Suwannee states there is nothing to report from the area.

Mr. Garrison Vandegrift from DOH Dixie/Gilchrist/Levy states there is nothing to report from the area.

Mr. Rel Perea from DOH Region 2 confirmed the dates of Florida Week at the CDP will be from April 14-20th of 2024, and that registration does not open until October.

EMS – Ms. Misty Woods from Alachua County Fire Rescue states the first stroke truck in Florida is housed at the UF Health Professional Park (the meeting location). Reports UF Health is working on acquiring two more stroke trucks to have in the state. Reports the stroke truck has already made a difference, and the team is working on public outreach and education regarding strokes. Alachua County Fire Rescue is working with the neighboring counties to develop a plan on how the different dispatch offices can coordinate and have the stroke truck respond/meet other county EMS personnel with a stroke alert patient.

Long-Term Care – Nothing to report.

At-Large Representatives – Mr. Kevin Towles from the Center for Independent Living reports they are moving forward with planning for the Emergency Preparedness Expos for individuals with disabilities, as these are funding through HCC training dollars. The Alachua County expo will be on March 14th and the Marion County expo will also be sometime in March. They are also working on grant funding to help get booster vaccinations for those with disabilities for COVID-19.

Ms. Lola Butler from FDOT reports she is continuing to engage with partners across the region in preparation for storm season. Reports there is an emphasis on mitigation funding and hazardous materials. Reports they continue to engage in training, especially with how much change/turnover there has been in the emergency management community.

Presentation – CDBG Health and Medical Lifeline Project: Healthcare Facility Infrastructure Protection and Resilience Planning Survey – Northeast Florida Regional Council

Planners from the Northeast Florida Regional Council presented to the membership the CDBG Health and Medical Lifeline Project, and the work the team has been conducting thus far. The presentation included the results from the Healthcare Facility Infrastructure Protection and Resilience Planning Survey. The presentation included a robust discussion between meeting participants and CDBG team members and provided feedback to the team on what to add to their work to make it more robust and suitable to facilities in the region.
